Submit All Required Items to Financial Aid Office

- Determine from your SAR if your application was selected for Verification. If selected, visit the portal to find out which Verification Worksheet you must complete. Find the worksheets at: financialaid.highline.edu
- Provide a tax transcript if you or your parents did not use the IRS data retrieval tool or tax filing information was changed after using the retrieval tool. Request a Tax Transcript directly from the IRS by going to their website **irs.gov** or by calling 1-800-908-9946.
- If your citizenship status is not confirmed on your FAFSA, bring your I-94, I-151, I-551 (green card, permanent resident card), or U.S. Passport, etc. to the Financial Aid Office and we will make a copy.
- If your Selective Service status is not confirmed on your FAFSA, you must provide proof of Selective Service registration or proof you entered the United States after your 26th birthday and were, therefore, not required to register with Selective Service. Find the application at **sss.gov**
- Provide any other documents that may be required, such as a copy of your social security card or high school diploma or GED.
- Provide proof of regained eligibility for financial aid from the Department
- of Education if you are in default on a federal student loan or owe a repayment on a federal grant.
